Announcement of Saudi Arabia Vision 2030 10.2017, Mohammed bin Salman al-Saud announced NEOM City at the Future Investment Conference Saudi Arabia reduces its dependence on oil in preparation for future depletion of oil resources Announcing the <Vision 2030> policy to promote economic diversification. As part of this, it announced the construction of Neom City, a super-large future new city.



# THE LINE 다리인

Location: Eastern side of the Gulf of Aqaba, between the Sinai Peninsula and Egypt, on the northwestern coast of Saudi Arabia. Area: 26,500 square kilometers, which is 44 times the size of Seoul. Scale: Expected total investment of \$500 billion approximately 670 trillion won).

A linear city on the desert.

A city built by erecting 500m glass-walled buildings in a straight line spanning 170km, envisioned as a hub for advanced technologies such as autonomous vehicles and floating islands. The goal is to have a population of one million by 2030. Ultimately, the city is expected to accommodate nine million residents upon completion.

## **DXAGON** 옥시곤

A state-of-the-art industrial complex floating on the sea, is set to begin in full swing this year. The planned city is designed to accommodate 17,000 residents and currently includes the construction of 71 residential towers and various auxiliary facilities. It can serve as a supplier and also participate in all aspects of urban development.





# TROJENA ERML

## "A mountain tourism city"

Is a project to develop a large-scale mountain tourism destination at an altitude of 1,500 to 2,600 meters. It aims to offer outdoor skiing and adventure sports year-round, along with additional features such as lakes, to create a global landmark.

# King Salman Park 광살만파크

Total project cost: about 32 trillion won Development plan announced in March 2019 It is the world's largest urban park in Riyadh, Saudi Arabia, with a size of 16km<sup>2</sup> and a combination of culture, art, and nature.

Forming a one-team Korea jointly with the public and private sectors, we devise a plan to actively support Korean companies in all directions, including diplomacy and finance, to win orders for large-scale overseas projects.

#### · Discover a project

The role of providing and supporting information in various fields, such as feasibility study, bidding, and financial support, such as information and statistics required by local active enterprises from the planning stage to the completion of the project.

#### • Dispatch of orders

In addition to the construction industry, various industries such as the Ministry of Land, Infrastructure and Transport sent an order support group to Saudi Arabia from November 4-9, 2023 to foster culture and technology such as land transportation, construction, mobility, smart city, IT, and smart farm as new high value-added businesses in the future

#### President's Visit to Saudi Arabia

In October 2024, the Korean President visited Saudi Arabia and signed a memorandum of understanding of about 200 businesses between Saudi companies and their partners.

The president is also interested in relations with Saudi Arabia to the extent that he believes he will head the country's economy.
